
General Instructions:-

- 12th Jan: Final list of events-wise participants must be submitted by 17:00 hours (at classification office) on 12/01/2020. Thereafter no change will be allowed in names nor any adjustment in competition schedule will be entertained. Technical committee meeting at 17:00 hours on Balewadi shooting Sports Complex on 12/01/2020
- Only two details for each event will be made (except for 300mtr) to accommodate weapon sharing.
- All matches/events will be conducted as per ISSF clubbed with AIPSCB rules to promote sports.
- 4) Medal presentation ceremony will be held immediately after finalization of results for each event every day. Time will be notified depending on finalization of result.
- 5) About 20 minutes PET on 10, 25 and 50 mtr. will be given in the evening for the next day event, only if respective range is cleared timely after the competition. Timings will be notified.
- 6) Due to limited number of targets and manual scoring, 300 mtr. events/matches will start on 13/01/2020 morning and next event will be commenced immediately on completion of particular event, so as to complete the competition well on time before closing ceremony.
- 7) Opening & Closing Ceremonies :
 - i) Rehearsal for opening ceremony will be held on 13/01/2020 at 1530 hrs at Badminton Hall Balewadi.
 - ii) Opening ceremony will take place at the same place on 14/01/2020 at 1600 hrs.
 - iii) Rehearsal for closing ceremony will be carried out on 17/01/2020 at 1530 hrs at Badminton Hall Balewadi.
 - iv) Closing ceremony will take place at the same place on 18/01/2020 at 1600 hrs.

INTRODUCTION

13th All India Police Shooting (Sports) Championship - 2019 will be held at Balewadi shooting range (Located at Shiv Chhatrapati Krida Sankul, Mhalunge-Balewadi, Pune) and Wadachi Wadi Firing Range (Located at Wadachi Wadi, Undri, Pune) from 13.01.2020 to 18.01.2020. Maharashtra Police will host the Championship.

1. LOCATION OF RANGE:

Balewadi Shooting Range is about 17 kms from Pune Railway Station and 22 Kms from Pune International Airport and Wadachi Wadi Firing Range is about 30 kms from Balewadi.

2. ACCESSIBILITY

Pune is easily accessible by road, train and air. NH4 (connecting Mumbai with Bangalore) passes through Pune. Nearest Airport is at Lohegaon, which is at a distance of about 22 kms from Balewadi, Pune.

3. CLIMATE

Weather in Pune in January is pleasant, with daytime temperature is around 30° C and night temperature falls to 11° C. Carrying a normal jacket/sweater will be sufficient.

4. RECEPTION AND REPORTING

Reception centres with responsible officers will be established at Pune Railway Station and at Pune Airport. These centres will start functioning from 10th January 2020. All contingent commanders are requested to intimate their, as well as their team's travel plan well in advance to enable us to arrange proper reception, transport and accommodation. Officers and members of the team shall make their own return journey arrangements. The teams should report by 12.01.2020 FN at Pune.

5. ACCOMMODATION

Accommodation will be provided for the Team members at Pune. Separate accommodation will be provided for the Team Managers & Officials as well as participants in the rank of Gazetted Officers. All personnel should bring their own bedding. It will not be possible to provide family accommodation to any officer accompanying the Team.

6. PARTICIPATION

All State police /UTs and CPOs Teams are likely to participate in the 13th All India Police Shooting (Sports) Championship -2019. The Schedule of Events will be sent later. <u>The Teams should report on 12.01.2020 FN at Pune</u>, without fail.

7. ELIGIBILITY CONDITIONS

All participants shall have been enlisted in the organization for a continuous period of not less than three months before the date of commencement of the games. A certificate of such eligibility shall be furnished by the head of the police force or an officer not below the rank of IG duly authorized by him for the purpose, and such certificate shall be appended below the nominal roll of the team which is sent to the host for the entry of the team. Every competitor participating in the championship should be borne on the strength of the organization. Entry of one particular competitor will be restricted to the number of matches as provided for in the General Rules by All India Police (Sports) Control Board, New Delhi.

8. ENTRY FORM, NOMINAL ROLL AND ENTRY FEE

9. CONDUCT

The All India Police Shooting (Sports) Championship will be conducted as per the ISSF (International Sports Shooting Federation) Rules and Regulation as amended from time to time subject to conditions prescribed in the General Rules for AIPSSC by the AIPSCB New Delhi. The tentative schedule of events is enclosed as Appx-A and Appx-B.

10. OFFICIALS

Well qualified and NRAI accredited officials will be employed. However, in case of any deficiency, eminent shooters/administrators accompanying the teams will be detailed for officiating.

11. PRACTICE

The entire Participants will be given dry practice/training at the Balewadi Shooting Range on <u>13.01.2020</u> as per Rules and availability of time.

12. WEAPONS & AMMUNITION

All teams will bring their own weapons & required ammunition for practice and firing competition. Magazine facilities for keeping arms and ammunition will be provided by organizers.

13. OPENING / CLOSING CEREMONY

All firers should participate in the Opening / Closing ceremony.

- a) Dress Order: Teams should have good dress for the March-past. All participants in a team shall wear the same dress during March-past.
- b) The teams shall also bring their unit flags of the following dimensions :

6 feet \times 4 feet - 01 No. For hoisting on flag post.

3 feet \times 2 feet - 01 No. For march-past.

- c) Team Managers Meeting will be held at the **Balewadi Shooting Range on** 12.01.2020 at 17.00 hrs.
- **d)** All team departures should be arranged on <u>18.01.2020</u> after the closing Ceremony is concluded.

14. REHEARSALS

There will be a full dress Rehearsal of both the ceremonies viz. opening and Closing in accordance with the norms of the police championship. The rehearsal of the opening ceremony shall be held on 13.01.2020, at 15.30hrs at the Balewadi shooting range Pune. The rehearsal for Closing ceremony will be held at the same venue on 17.01.2020.

15. PROTESTS

Protests, clarification if any; should be lodged by the team managers in writing to the Organizing Committee within 2 hrs after the completion of the match along with a protest fee of Rs.2500/-. The decision of the Jury of Appeal shall be final & binding on all the teams.

16. MESS

All the teams are requested to make their own arrangements for mess. They should bring with them sufficient number of cooks, class-IV employees, utensils, administrative staff to establish their mess at the accommodation centers provided for them. However, cooking gas will be made available on payment. An advance of 2500/- has to be paid on arrival, for this purpose. No fire food will be allowed for cooking.

17. MEDICAL

Medical Aid Post will be established at the firing Range.

18. SECURITY ARRANGEMENTS

In Order to ensure security, all officials and members of the team will be required to carry their identity cards. Every member of the participating team should bring two recent passport size photographs in uniform in purpose of preparing AIPSSC-2019 identity card. It is emphasized that all security related instructions displayed and communicated be strictly observed. Team managers/ in-charge are requested to ensure highest standards of discipline by their respective team members.

19. ARRRIVAL OF TEAMS

All participating teams are requested to reach Pune on 12th January,2020 FN. It is emphasized that it will not be possible to render any administrative assistance to the teams arriving at Pune before 12th January, 2020. All teams should intimate their arrival travel plan to the control room latest by 23 December 2019 to avoid any inconvenience. Since railways have their well established computer network throughout the country, return journey reservation may please be made by the teams themselves; as it will not be possible to arrange for railway reservation at short notice.

20. TRANSPORT

As most of the team and team managers are expected to come by train, vehicles will be provided to receive the team at Pune railway station to the place of stay. Vehicles will be provided to the Team managers/Captain for their transportation during their stay. It is emphasized that it will not be possible to provide individual vehicles to the officers.

21. DISCIPLINE

Very high standard of discipline is expected from all officers and men of the participating teams. Team managers will be personally responsible for orderly conduct of their team members during period of the championship.

22. ARMS & AMMUNATION AND OTHER EQUIPIMENT

All teams are requested to deposit their arms and ammunition at the strong room established at Balewadi shooting range, Pune. It shall be the responsibility of the teams/participants to ensure safe custody of the strong room. Team managers/incharge are advised to bring boxes with locking arrangements so that the weapons kept in the strong room are doubly secured.

23. UNIFORM

All the members of the participating teams are requested to be in their prescribed dress codes during various competitions and during the opening and closing ceremonies. All the competitors are advised to display their identity cards issued by the Organizing Secretary, 13th All India Police Shooting (Sports) Championship 2019

INTRODUCTION TO THE NINTH EDITION

Over a period of four years since the 8th Edition of Rules governing All India Police Sports Control Board and All India Police Games published in July 2008, there have been a number of changes/additions in the sports arena governing conduct of sports/games. It gives me a great pleasure in presenting the revised and up-to-date edition of rules to police force of the country incorporating all the amendments/changes in the Rules for conduct of All India Police Games. The highlights of 9th Edition include augmentation of financial assistance for organising various sports events, introduction of reward money for medal winners in national championship, enhancement of reward money for medal winners in Olympic, Asian and Commonwealth Games in order to encourage the police sportspersons to put in their best and scale a new height of success including induction of events viz. Judo competition for women and All India Police Commando Championship. Archery, one of the popular competitions at national/international level has also been introduced in the sports calendar of All India Police Sports Control Board from the year 2012. In the present edition, all changes brought about up to 30th November, 2012 have been incorporated.

INTRODUCTION TO THE FIRST EDITION

It was at the Conference of the Inspectors General of Police held at Delhi in 1950, that decision was taken in regard to the formation of an All India Police Athletics and Sports Meet Organisation, to promote sports and competitions in the Police Forces of the Indian Union in order to improve the esprit-de-corps and morale of the police forces in the country and particularly to establish better relations between the Police and the Public of India.

2. The IGPs elected a Committee called Central Sports Committee consisting of the Director, Intelligence Bureau as the Chairman, the IGP, SPE, the IGP, Delhi and the Commandant, CPTC, as members and one Deputy Director of the Intelligence Bureau as the Secretary. This Committee was to organise annual All India Police Athletics and Sports Meets and other All India Police Tournaments in various games. The Committee was to formulate all Rules and procedure for the smooth running of these Meets and Tournaments in order to improve the standards of the Police in this regard.

3. The Central Sports Committee unanimously agreed to accept and follow the Olympic Rules applicable to such competitions and tournaments and, therefore, accepted Buck's Book of Rules of Games and Sports (YMCA Publication) as its guide and has since been following these rules in regard to all the tournaments for sports and Games for the All India Police Forces that have since been organised. Besides these Rules, the Committee has from time to time formulated additional rules for the smooth and proper running of these tournaments. The Committee has now found it necessary to collate all the additional rules that have been formulated and publish them in this pamphlet for convenient reference.

4. In the first instance, in February 1951, the All India Police Athletic Meet was held at Cuttack (Odisha). Each state donated silver trophies for each of the 22 events that were competed for. A further donation from all States went towards providing of a large silver trophy for the Athletic Championship. The Orissa State-the host State for the first Meet, held at Cuttack donated the runners-up trophy. A special Silver Medal was donated by the Home Minister (Government of India) for the best athlete. Incidentally, this medal has since been donated regularly each year by the Home Minister (Government of India) and is a very coveted prize.

5. Soon after the first Meet, the Central Sports Committee was able to divide India into 4 Zones – the Northern, the Southern, the Eastern and the Central. This division was necessary in view of Hockey and Football Tournaments, which were first to be played out on a Zonal basis – the winning team of each zone competing later in the semi-finals and finals of the All India Police Hockey and Football Tournaments at the venue of the All India Police Athletic Meet. It was also decided that the Zonal tournaments would be held in rotation in their respective zones at a suitable venue in each state of that zone. Another decision taken was that the All India Police Hockey and Football Tournaments, would be held in rotation finals of the All India Police Hockey and Football Tournaments, would be held in rotation Zonal- wise. Consequently, the second All India Police Athletics and Sports Meet was held at Lucknow (Central Zone) in February 1952 and from this year onwards the semifinals and finals of the Hockey and Football Tournaments were held along with this Meet. The 3rd Meet was held in February 1953 at Bangalore (Mysore) – the Southern Zone, and the 4th in 1954 was held at Jalandhar (Punjab) – Northern Zone. It was from this 4th Meet that the Central Sports Committee was able to organise an All India Police Wrestling Tournament in 4 weights only. This tournament was also held first in each zone along with the All India Police Hockey and Football Tournaments. The winners of each zone met at the All India Police Athletic Meet to compete in the semi-finals and finals of this wrestling tournament. In the 5th Meet, which was held at Ranchi (Bihar) in February 1955, the All India Police Wrestling Tournament was enlarged to all 8 weights. The 6th Meet was held at Gwalior (M.P.) Central Zone in February 1956 and included the semi-finals and finals of the Hockey, Football and Wrestling tournaments.

6. The Central Sports Committee has decided to introduce an All India Police Gymnastics competition from the 7th Meet onwards and it is hoped that an All India Police Volleyball Tournaments will be added from the 8th Meet onwards.

7. The tournament in Hockey, Football and Wrestling are held on a knock-out basis in each zone. The All India Police Gymnastics and Volleyball Tournaments that are yet to be started will also be held on a knock-out basis initially in each zone. The semi-finals and finals of the All India Police Tournaments in all these games are also held on a knock-out basis. In the Hockey and Football Tournaments, hard-liner trophies are provided for the winners of the two loosing semi-finalists. Trophies for winners and runners-up of these tournaments have also been provided through donations made by all the Police forces in India – except the trophy for the winners of the All India Police Hockey Tournament, which was presented by the Raj Pramukh of the PEPSU State.

8. A tradition has been set from the very inception of these Meets and which is now carefully followed by all the host States either at the headquarters of the zonal tournaments or the headquarters of the All India Police Tournaments, for the games to be declared 'Open' by the Chief Minister of the State after the Olympic ceremony has been performed. Similarly, the Governor of each State (host) has declared the Games closed again after the closing ceremony, as laid down under the Olympic Rules.

9. It has also become a tradition for the host State to provide the spectators and the athletes with the entertainment of a Police Tattoo as a conclusion to the Games

- soon after the closing ceremony and the prize distribution. It is also traditional for the host State to provide for a community Dinner (Barra Khana) as a 'Finale' to the Games and at which the Governor, the Chief Minister and other Ministers of the State Cabinet, the officials and all the competitors dine together

10. The host states of both the zonal tournaments as well as the All India Police Tournaments provide all visiting teams with accommodation, lighting and conservancy and make arrangements under their personal supervision for the messing of all the teams. The visiting teams, however, pay for their boarding charges at fixed rates to the caterers appointed by the host state. The host state also provides transport for each visiting team from the railway station to the venue of the Meet and it has now become traditional to provide the visiting teams with transport for sightseeing purposes. The host state also provides either a cinder or a grass track for the Athletic Tournament and playing fields with standard equipment for the Hockey and Football tournaments. The host state also provides a wrestling ring or platform with all the equipment and lighting necessary for the tournament. In future 'host state' will provide all equipment necessary for the Gymnastics and Volleyball Tournaments that are envisaged.

11. A very high standard of discipline is maintained in the camp where all the visiting teams are accommodated.

12. So far six Meets have been held and at each of these, the host State produced a souvenir in which the messages of the Prime Minister, the Home Minister and other messages received from various dignitaries have been published.

RULES OF THE ALL INDIA POLICE SPORTS CONTROL BOARD

1. <u>Short title & Editions</u>

- (a) These Rules may be called All India Police Sports Control Board Rules.
- (b) They shall come into force from December 01, 2012 and shall be communicated to all concerned.
- (c) These Rules shall apply to all organised sports activities controlled and patronized by the members of the All India Police Sports Control Board, registered as Society No. S2853 of 1965-66 dated October 20, 1965 under the name 'THE ALL INDIA POLICE SPORTS CONTROL BOARD'.

2. <u>Definitions</u>

In these Rules, unless the context otherwise requires or indicates:-

- (a) 'Board' will mean the All India Police Sports Control Board.
- (b) 'Chairman' means the person duly elected as Chairman of the Board by the Council.
- (c) 'Council' means the General Body of the Board consisting of Heads of all States/Union Territories Police Forces, Central Police Organisations.
- (d) 'Governing Body' means the Board.
- (e) 'Member' means a Police Force of any State or Union Territory of India, or Central Police Organisation of the Union of India.
- (f) 'Police Force' means and includes, Police organizations of various States and Union Territories in India and Central Police Organisations.
- (g) 'Secretary' means the person duly appointed as 'Secretary-cum- Treasurer' of the Board

3. <u>Objects</u>

The aims and objects of the Board shall be to organize and conduct the All India Police Games and the All India Police Duty Meet once a year and any other event connected with athletics, sports, games or the profession with a view to achieve the following objectives:-

- (a) Encourage the growth of healthy competition in the field of sports, games and athletics among the Police Forces and to foster and develop an esprit- de-corps amongst the members.
- (b) Formulate Rules/policies for conduct of sports activities among police forces of India and its review from time to time.
- (C) Dissemination of useful knowledge regarding all types of sports among the Police Forces of India.

4. <u>Membership</u>

The membership of the society shall be open to all States/UTs Police Forces of India and Central Police Organisations.

5. <u>Council</u>

The supreme authority of the Board shall vest in a Council consisting of Heads of State/Union Territory Police Forces and Central Police Organisation or their duly authorised representatives not being below the rank of I.G. In case the Head of a State Police Forces & CPOs is unable to attend the meeting of the council, an officer, regardless of his rank, duly authorised by him shall be entitled to attend the meeting of the Council and exercise full rights of a Member.

6. Powers and duties of the Council

The power and duties of the council will be as follows::-

- (a) To elect/appoint the office bearers and members of the All India Police Sports Control Board and any such other standing or ad-hoc committee as it may think necessary for carrying on the work of the Society.
- (b) To examine and adopt the periodical reports submitted by the All India Police Sports Control Board.
- (c) To enunciate principles according to which the All India Police Sports Control Board shall operate.
- (d) To approve the induction of new items of sports in the All India Police Games.
- (e) To receive subscription for the Central Fund or authorize to do so, and to render financial assistance towards holding the All India Police Games, All India Police Duty Meet and other events connected with sports, games or the profession including other sponsored activities.
- (f) To take such other steps as may be necessary or expedient to carry into effect the objects of the Board.

7. <u>Composition of the Board</u>

The following shall constitute the Board:-

- (a) Chairman, the Director, IB will be the ex-officio Chairman.
- (b) Secretary-Cum-Treasurer.
- (c) Members (minimum 4 but not more than 8 Heads of Police Forces)
- (d) Any other member, co-opted for any specific purpose by Chairman of the Board.

The Secretary and Members shall hold office for two years unless they resign earlier.

8. <u>Powers and duties of the Office Bearers</u>

(a) The office bearers of the Board shall be part-time functionaries and in honorary capacity

(b) <u>Chairman</u>

The Chairman shall preside over the meeting of the Board and he shall arrange to convene at least one such meeting every two years. One third of the total number of members shall form the quorum. In case of equality of votes during voting, he shall exercise casting vote. If, in the opinion of the Chairman, any matter has arisen which requires immediate action, he shall take such action as he deems necessary and shall intimate the same to the Council or the All India Police Sports Control Board whichever in the ordinary course would have dealt with the matter.

(c) <u>Secretary</u>

- (i) The Secretary shall be appointed by the Chairman in consultation with the Council. He shall carry on the correspondence on behalf of the Board and give effect to the resolutions of the Council/Board. He shall issue notice of meetings and record minutes of the same and shall be responsible for the maintenance of other records or registers as well as the custody of all papers of the Board and carry out other duties that may be entrusted to him.
- (ii) In his capacity as Treasurer, the Secretary shall exercise general supervision over the funds of the Board. He shall receive all subscriptions and donations and keep a regular account of the receipts and disbursements. He shall be responsible for all amounts received by the Board and shall

issue receipts for the same on the official form. He shall also submit to the All India Police Sports Control Board an annual statement of receipts and expenditure and the audited balance sheet.

- (iii) He shall file Income Tax Return for Board fund and liaise with Income Tax authorities for scrutiny of Board account and other related matters.
- (iv) He shall be authorised to sign cheques upto a maximum of Rs. 1,00,000/-. Cheques above Rs. 1,00,000/- shall be countersigned by the Chairman.
- (v) The Chairman may appoint an Assistant Secretary and an Assistant Treasurer to assist the Secretary-cum-Treasurer in the discharge of his duties.

(d) <u>Members</u>

A member of the Board shall be elected by the Council from out of its members and they shall attend meetings of the Board. They shall discharge such duties as shall be assigned to them by the Chairman of the Board and shall assist the Chairman and the Secretary in their executive functions.

9. General Body Meeting or Meeting of the 'Council'

- (a) A general body meeting or a meeting of the Council shall be held at least once every year.
- (b) One-fourth of the total number of members along with the Chairman and the Secretary shall constitute and form the quorum.
- (c) In the absence of Chairman of the Council, the Senior-most member of the Council present shall preside over the Council Meeting

10. Special meeting of the Council

- (a) Special meeting of the Council may be called at any time at the discretion of the Chairman.
- (b) In the interval between two meetings of the Council, any action may, if so desired, be taken by the Chairman after consulting the members through correspondence.
- (c) At any special meeting of the Council, one-fourth of the total number of members shall form the quorum

11. List of Governing body shall be filled u/s 4 of the Societies Registration Act 1860 once every year or before the fourteenth day succeeding the day on which the General body meeting is held.

12. <u>Amendments</u>

Whenever it shall appear to the Board that it is necessary to alter, extend or abridge these rules for any purpose within the meaning of Societies Registration Act (21 of 1860) or to amalgamate the Board either wholly or partially with any other similar society or Board, the Board shall submit the proposition u/s 12 and 12A of the said Act to all the members in a written or printed report and shall convene a special meeting of the Council for consideration of the proposition. If the proposition is approved by three firth of the number of members present and voting, the same shall be implemented.

13. Dissolution of the Board and Adjustment of its affairs

At the Council meeting, when not less than three fifth of the number of members present and voting determine that the Board shall be dissolved forthwith or at a later date, all necessary steps shall be taken for the dissolution and settlement of the property of the Board, its assets and liabilities.

Provided that the Board shall not dissolve itself without the consent of the MHA (Government of India).

14. Distribution of assets on dissolution

If upon the dissolution of the Board there shall remain, after settlement/adjustment of all the debts and liabilities, any property whatsoever, the same shall not be paid to or distributed among members of the Board, or any of them, but shall be given to any other Society, to be determined by the votes of not less than three fifth of the members present at the time of dissolution.

15. <u>Powers of the Board</u>

The Board shall exercise the following powers:-

- (a) All affairs of the Board shall be conducted by the Board and it shall be its duty to see that the general provisions and the bye-laws of the Society are complied with in all respects.
- (b) The Board shall sanction and control expenditure and shall generally supervise & conduct the business of the Society
- (c) The Board shall examine and decide all questions brought before it.

- (d) The time and place for meetings of the Board shall be fixed by the Chairman and a notice shall be issued by the Secretary to each member well in advance.
- (e) The agenda for the meeting shall also be circulated along with the notice.
- (f) If, for any reason, the Board is not able to meet on the appointed date, decisions on agenda points may be taken by the Chairman/Secretary after consulting the members of the Board through correspondence.
- (g) The Secretary may, after consulting the Chairman, take any action on urgent matters that may be necessary in the interest of the Society and report the same as soon as possible to the Board for ratification.
- (h) The AIPSCB shall fix the hosts and dates of the All India Police Games and the All India Police Duty Meet.
- (i) The Board shall appoint auditors and fix their remunerations. It shall also pass the audited statement of accounts. It shall hold, control and administer the property and the funds of the Society through the Secretary-cum-Treasurer. These powers will be subject to supervision and direction by the Council.
- (j) The Board may add to and/or amend existing rules for conduct of the All India Police Games/All India Police Duty Meets or any other event connected with sports/games and the profession as and when considered necessary. All such amendments/additions shall come into force immediately and be notified to all the members.
- (k) In regard to any matter not specifically provided for in these rules, it shall be lawful for the Board to do such thing or take such action as may be just and proper in the circumstances of the case.
- (I) Information about all such actions shall be placed before the Council at the first opportunity for ratification.

16. Place of Meeting

All the meetings of the Council, the Board and other committees shall be held at New Delhi, unless otherwise directed by the Chairman, or the Council.

17. <u>Technical Experts Committee</u>

In order to formulate systematic plans for improving the standard of games and athletics by advice and training, a Technical Experts Committee may be constituted by the Board. This Committee shall consist of the Secretary of the Board and five experts from among the Police Forces in the country. At least one expert shall be from each zone. Three members shall form the quorum of a meeting of the Experts Committee. The Secretary of the Board or the senior most among the members present shall preside. He may also co-opt other members for any particular purpose or meeting.

The Board shall be competent to replace the members of the said Committee at any time.

18. <u>Logo</u>

The meeting of the All India Police Sports Control Board held on September 3, 1998 decided to change the logo of the All India Police Sports Control Board. In new logo, the 5-pointed star has been retained but the 20 inter-linked circles, representing 20 States of India, have been replaced by 3 larger inter-linked circles each representing the States/Union Territories/Central Police Organisations. The star, inter-linked circles and the ribbon below the inter-linked circles carrying the word "All India Police Sports" would be in gold against a navy blue background. A sketch of the new logo in black and white is given below:



19. <u>Central Fund and Subscription</u>

- (a) The Board shall have a fund known as the 'Central Fund'. Each member shall pay to the "Central Fund" such subscription as may be determined from time to time by the Council.
- (b) No member shall be entitled to vote in any proceeding of the Board or be counted as a member or be eligible to participate in any sports events of the Society whose subscription at the time shall have been in arrears for a period exceeding three years.
- (c) The rate of contribution for the fund is Rs. 10/- per capita of its actual strength each year or at such rate as may be decided by the Council or the Board from time to time. The rate of contribution has been enhanced to Rs.20/- which would be effective from the financial year 2019-20. All money received as contribution or otherwise to the credit of the fund shall be deposited forthwith in an account with the State Bank of India.

20. All provisions of the Societies Registration Act (21) of 1860 (Punjab Amendment Act 1957) as extended to the Union Territory of Delhi shall apply to this Society which has been registered as Society No. 2853 of 1965-66 dated October 20, 1965 under the name All India Police Sports Control Board.

21. <u>Repeal</u>

All rules and orders relating to the matters covered by these rules shall stand repealed in so far as they are inconsistent with any of the provisions of these rules.

Notwithstanding such repeal, anything done or any action taken under the provisions of the rules or orders so repealed shall in so far as such thing or action is not inconsistent with provision of these rules be deemed to have been done or taken under the provisions of these rules as if the said provisions were in force when such thing was done or such action was taken and shall continue in force accordingly until superseded by anything done or any action taken under these rules.

ALL INDIA POLICE GAMES RULES

1. <u>Short title and application</u>

These rules shall be called the "All India Police Games Rules" and shall apply to the organization and conducted by the All India Police Sports Control Board of all events connected with athletics, games and sports that may be organized at specified periods.

These rules shall come into force with effect from **December 01, 2012.**

2. <u>Definitions</u>

- (i) 'Games' mean all events connected with athletics, sports and games organised by and at the behest of the All India Police Sports Control Board.
- (ii) Board means the All India Police Sports Control Board
- (iii) <u>**'Host'**</u> means the Head of the Police Force of the State/CAPFs nominated for the purpose of organising and conducting the games.

3. <u>Object</u>

The object of these rules is to prescribe guidelines for smooth organisation and conduct of the games.

4. <u>Format</u>

The games shall be organised once every year.

5. <u>Events</u>

- (a) The games shall comprise the following tournaments:-
 - (i) All India Police Hockey Championship (Menonly)
 - (ii) Shri B.N. Mullik Memorial All India Police Football Championship (Men only)
 - (iii) All India Police Volleyball Cluster consisting;
 - 1. Volleyball Championship(Men & Women)

For the sake of convenience, the All India Police Volleyball, Basketball, Handball and Yoga Championships may be held together at one place by one host. Similarly, the All India Police Wrestling, Weightlifting, Kabaddi, Boxing and Body Building Championships may be staged together. Likewise, All India Judo, Gymnastics, Wushu & Taekwondo may also be held together at one place.

(b) The Board shall, in-consultation with the Heads of Police Forces, fix the venue and dates for the aforesaid games/events and inform all concerned accordingly. The host shall, thereafter, issue detailed joining instructions to all concerned with a copy to the Secretary, All India Police Sports Control Board.

6. <u>Organising Committee</u>

The host shall appoint, for the smooth and efficient conduct of the Games, the following Committees:-

(a) Organising Committee

This may include the Head of the host Police Force as Chairman besides an Organising Secretary and a few senior officers as decided by the host. In normal course, the appointment of Organizing Secretary should not be below the rank of DIG.

(b) <u>Sub-Committee</u>

These may be constituted for reception, publicity, boarding/lodging/refreshment, transport and communication, medical facilities, security, ceremonies, games/events, ground equipments, programming, records/results etc. Director of Competitions may also be appointed wherever necessary.

(c) Jury of Honour and Appeal

This may be constituted by the host and include the host and such other senior officers, retired senior police officers and office bearers of the concerned national/state federations, Secretary of the All India Police Sports Control Board and the Organising Secretary of the particular games.

7. <u>Eligibility</u>

All participants in the games, other than gazetted officers of and above the rank of Deputy Superintendent of Police, shall have been enlisted in the organisation for a continuous period of not less than **three months** before the date of commencement of the games. **SPOs of J&K Police as well as of any other States/UTs/CAPFs, are not allowed as they are not enlisted in their respective**

organization. Further, no one below the age of 18 years shall be eligible to participate in the games except in swimming and gymnastics in which the sports persons below the age of 18 years may participate. A certificate of such eligibility shall be furnished by the Head of the Police Force or an officer not below the rank of IG duly authorised by him for the purpose, and such certificate shall be appended below the nominal roll of the team which is sent to the host for the entry of the team.

8. Entry and Entry Fee

Each Police force may send a maximum of two entries (three entries in case of athletics events) for an individual event and one team for the team events. For the marathon race being the longest distance race, the AAFI has permitted three entries from each unit. The strength of the teams, including the reserves but excluding the manager, coach, doctor etc. will be as follows:-

Each police force shall send the names of all its participants, including those in the reserve, team manager, coach and doctor to the Organising Committee by the notified date. On receipt of these entries, the host Police Force will allot chest and back numbers to every participant wherever applicable including in athletics, alongwith those in reserve.

The entry fee shall be at the uniform rate of Rs. 100/- per participant, including the reserves, managers, coaches and doctors for various games/athletics (Revised w.e.f. December 14, 2017).

9. <u>Mode of payment of entry fee</u>

The entry fee shall be paid along with the entry forms for respective meets to the host organization, which may use it for meeting the expenditure on the Meet. It may be paid either in cash or through a bank draft or a local multi city cheque. No outstation cheques would be admissible. The host may specify in joining instructions the exact name/designation in whose favour cheques/bank drafts towards the entry fee should be prepared.

10. <u>Conduct of the Games</u>

The teams and individual participants of all police forces shall be given direct entry into the various All India Police championships.

In hockey, football, volleyball, basketball, handball and Kabaddi, the participating teams, depending on their number, would be divided into a few separate pools (ideally four but the number can be modified by the host to meet the requirements of the situation). The tournaments in these games would be played on league basis in each pool to decide the top two teams from each pool, which would thereafter compete on a knock-out basis. In the league matches, the winning team would be allotted two points, the losing team zero point and in case of a draw, the two teams shall share one point each.

THE JUDO COMPETITION would be held under the Double Repechag System or the latest system prescribed by the Judo Federation of India, in the following weight categories with the proviso that an individual competitor can participate in only one weight category, i.e. either in his/her own weight category or in a higher weight category.

THE GYMNASTICS COMPETITION shall take place in 6 events, i.e. Floor Exercise, Pommelled Horse, Roman Ring, Vaulting Horse, Parallel Bars and Horizontal Bar. The rules followed by the Gymnastic Federation of India and amended from time to time, would be adopted in the All India Police Games. Since there is no compulsory series in any of the Olympic, world or international gymnastic championships, the compulsory series have also been abandoned from the National Gymnastic Championship. Considering the limited number of participating teams in the All India Police Gymnastic Championship, competitions No. 1 & 2 i.e. the individual and all round championships may be decided on the basis of qualifying competition No. 1 and apparatus finals and the team championship competitions may be conducted as usual.

THE WEIGHTLIFTING COMPETITION would be held as per the latest rules of Weightlifting Federation of India in the following weight categories for men and women with the provision that an individual competitor can participate in only one weight category, i.e. either in his/her own weight category or in a higher weight category.

The ALL INDIA POLICE GOLF AND LAWN TENNIS Championships would be held for Gazetted Officers whereas BADMINTON TOURNAMENT would be organised for both Gazetted Officers & Non Gazetted Officers (w.e.f. December 14, 2017).

11. The Chairman/Secretary of the Organising Committee shall arrange to draw ties, preferably in presence of the team managers and observers of the AIPSCB at least one day before the commencement of the competitions. However, in case of judo, wrestling, boxing and weightlifting competitions, the arrangements to draw ties would be made at the time of the weighing-in of the competitors. For athletics, the schedule of events shall be drawn by the Organising Committee and circulated to various participating teams at least a fortnight in advance. A suggested schedule of events is given in Appendix 'A' but it is only illustrative and can be modified by the Organising Committee to meet the demands of the situation. The Organising

Committee is competent to make any subsequent change in the schedule that may be considered necessary but these should usually be made through a consensus without harming anybody's interest.

12. The All India Police Games, in different disciplines, shall be conducted as per the latest rules of the respective National Sports Federations.

13. A clinic of Team Managers shall be held a day prior to the commencement of the competitions.

14. The results of the heats/rounds /matches etc. should be announced over the loudspeakers immediately on their conclusion. A consolidated bulletin, containing the day's results may also be issued in the evening by the organisers. On the conclusion of the tournament, the consolidated results shall be sent to the AIPSCB at the earliest with a copy to each of the participating teams.

15. <u>Settlement of protests</u>

A protest may be lodged against any decision or other matter relating to the Games by any participating team through its Manager with the Organising Committee, in writing and addressed to the Chairman/Secretary/Director of competition of the Organising Committee and shall be made within two hours of completion of the event/declaration of result which ever is later. However, protests concerning the status/eligibility of any participant can be made either before the commencement of the event or within two hours of his first participation in the event/Meet. A sum of Rs. 2500/- shall be paid as protest fee in each case by the Manager of the team lodging the protest to the Organising Committee. The jury of appeal shall take decision and communicate to all concerned (in writing) as early as possible but not later than the MEDAL AWARD CEREMONY of that particular event for which the protest has been lodged. The decision of the Jury of Appeal in respect of the protests lodged shall be final.

16. <u>Duration of the Games</u>

The exact duration of different All India Police Championships may be decided by the host keeping in view the total number of participating teams and players. The total duration may, however, range from a minimum of four days in case of the athletic meet to around 12 days (including opening & closing ceremony) in case of the hockey and football championships.

The suggested programme of the Athletics Championship is at Appendix-A

17. Opening and Closing Ceremonies

There shall be an opening and a closing ceremony on the day of the commencement and conclusion respectively of various championships. The host may invite, in consultation with the Board, an eminent person to preside over these

ceremonies. A broad format of the programmes to be followed during these ceremonies is at Appendix 'B'.

The host will organise a 'Barra Khana' for all the participants, team managers, organisers and invitees preferably in the evening after the closing ceremony. Some guidelines in the matter are suggested at Appendix 'C'.

18. <u>Medals</u>

Medals shall be awarded to the winners of the first, second and third places in various events and team championships. In addition, certificates shall be awarded to those securing the first six places in athletic events and the first three places in other events. An attested copy of the certificate so awarded may be put in the Character Rolls/Annual Confidential Reports of the recipients. Medals to be awarded would be arranged by the Board and sent to the host organization before the commencement of the concerned Meet. The host will get the certificates printed in the standard proforma and will be signed by the host Chief of Police and the Organising Secretary of the Meet (Appendix 'D').

Medals in individual events would be ceremonially presented (Appendix 'E') immediately after the conclusion of the particular event while the trophies and medals for members of the winning teams would be presented at the closing ceremony of the championship.

19. Trophies

A list of all rolling trophies to be awarded for various events is at Appendix 'F'. Joint winners of a trophy will share the custody, with the host deciding through the toss of a coin as to who would keep the trophy for the first six months.

In the individual events viz. wrestling, judo, weightlifting, boxing, **Taekwondo**, **Wushu, Body Building etc**, the medals won by both the competitors of a particular team in a particular weight category are to be counted for deciding the team championship.

The responsibility of safe custody of Trophies lies with winning team of the year. Any damage or loss caused during transit will be made good by the organisation concerned.

Trophies shall be returned to the Secretary, All India Police Sports Control Board at least 45 days before commencement of the next championship.

20. Athletics (New Rules-AFI)

The Athletic Federation of India has revert back to point system w.e.f 2012 for deciding team championship, to be calculated for the first six places as under:-

1 st place 2 nd place	7 points
2 nd place	5 "

The team championship would be decided while awarding points as mentioned above. In case of tie:-

- (i) Team winning more Gold Medals will be winner
- (ii) If tie still remains, team winning more Silver Medals will the winner
- (iii) If tie still remains, team winning more Bronze Medals will be the winner and failing that
- (iv) Team with more number of Gold Medals in individual events & so on

21. Equipment

The Organising Committee shall arrange to provide footballs, basketballs, volleyballs, handballs & hockey balls, wrestling, gymnastics, Judo, boxing, **Taekwondo, Wushu, Body Building,** weightlifting apparatus/equipments and refreshments for the participating teams

The host shall ensure that the equipment, playing fields etc., used in the games are of standard quality and in serviceable condition, as prescribed by the respective National Federations.

The host shall submit to the Board at least four weeks before the commencement of the All India Police Games a certificate that the apparatus and equipment obtained or prepared by them for use in the Games are of the standard prescribed by the concerned National Federations. The Board, if it so wishes may nominate a member or members of its Technical Committee to inspect the equipment. Such inspection shall be completed well before the commencement of the tournament/games so that replacement can take place wherever needed.

22. <u>Umpires and Referees</u>

The Organising Committee shall arrange qualified umpires/referees/technical officials from amongst those figuring on the panels approved by the respective National or State Federations. It is also advisable to have a proper mix of umpires/referees hailing from the host State and those from outside.

23. <u>Clothing/Uniform/Flags</u>

While participating in the opening and closing ceremonies, all the members of a particular team/contingent should wear identical dress (be it track suits, blazers, pants/vests etc.) Each participating team shall bring two flags, one of the size of 6' x 4' for hoisting at the venue (along with the flag of AIPSCB) and the other of the size of 3' x 2' to be carried by the team leader during the march past at the opening and

closing ceremonies. During competition, all participating teams shall wear a vest/shirt of a distinctive colour with the name of concerned Police force clearly printed on it so that it is visible from a distance. Chest and back numbers, where allotted, shall also be clearly displayed.

24. <u>Discipline</u>

(a) The Jury of Appeal constituted by the host organisation shall act promptly and impartially in all cases of indiscipline coming to its notice. At least one member of the Jury of Appeal shall always remain present during every event.

(b) The Jury of Appeal will be empowered to take disciplinary action including disqualification against any participant who is guilty of misconduct on the field on written complaint by the umpires.

(c) The Jury of Appeal shall also take drastic action in cases of proven guilt, which shall include a minimum punishment of deduction of maximum points, which are otherwise awarded in the event.

(d) On receipt of a report from the Jury of Appeal, the DGP/IGP of the host State/UT/CPO will report to the Board all cases of serious misconduct by any participant for any action that the Board may consider necessary with regard to the future participation of that individual in any tournament/competition.

25. <u>Making draw of lots/pools</u>

It is mandatory for all the host organisations to make the draw of lots/pools/fixtures, wherever necessary, in the presence of all the team Managers/Coaches and representatives of All India Police Sports Control Board during the Manager's meeting/clinic itself.

26. <u>Fixtures.</u>

The All India Police Sports Control Board has decided to introduce **pre- quarter final matches in Football Championship. The Championship, in future, shall be organised as per the prescribed rules of All India Football Federation.** However, the Board has decided to draw a line of pool clash in Volleyball, Handball, Basketball and Hockey Championship from quarter final level onwards, as per the rules of concerned federations.

In Kabaddi, the draw of pools/fixtures would be finalized as per the rules of Kabaddi Federation of India. (6 groups giving weightage to first 12 teams where first four teams would be given bye at pre-quarters level and first draw of balance 8 teams followed by draw of other teams for allotment of pools would be made).

The remaining part of the expenditure can be raised by the host through contributions from the government, sponsorships, advertisements etc. A certificate shall be sent by the Chairman/Organising Secretary of the Championship to the All India Police Sports Control Board, within three months from the date of conclusion of the Championship, to the effect that financial assistance received from the Board was fully spent. If some amount had remained unused, it should be promptly returned to the Secretary of the Board. 28. In national level meets organised by the Federations to which AIPSCB is affiliated, the AIPSCB will field an Indian Police Team and it shall be compulsory for the sportspersons selected for the Indian Police Team to participate on its behalf. In case any police department, separately affiliated with the concerned Federation, proposes to field a team on behalf of its own organisation, it may do so, but sports persons from the organisation if selected for the Indian Police Team, would not form part of their departmental team.

The AIPSCB shall give cash reward to Police Sportspersons winning medals in various National Championship at the following scales:- (New Delhi January 11, 2012)

Gold Rs. 35,000/-, Silver Rs. 20,000/-, Bronze - Rs. 15,000/-

29. The following cash rewards will be given by AIPSCB to the outstanding police sportspersons who won medals in the Olympics, Asian Games and Commonwealth Games (Revised w.e.f. January 2012)

Besides, those bettering national records (not merely equalling) would be given a cash reward of Rs. 50,000/-. Sportspersons who are awarded prestigious **Rajiv Gandhi Khel Ratna Award, Arjuna Award & Dronacharya/Dhayanchand Award would be given Rs.** 1,50,000/-, 1,00,000/- and 50,000/- respectively (w.e.f. financial year 2015-16).

30. The AIPSCB has abolished the present system of "bye" in the All India Police Games. However, seeding would continue, in accordance with the performance of the teams in the last championship, so as to ensure that the stronger teams may not play against each other at the initial stage.

The number of non-playing participants should not exceed 15% of the total strength of the contingent.

32 The Dope Tests in All India Police Athletics, Judo, Gymnastic, Wrestling, Boxing, Aquatic & Cross Country, Weightlifting, **Wushu, Taekwondo**, **Body Building**, Commando and Water Sports competitions will be conducted every year. Whereas, in other sporting events, random dope tests can be arranged by the host organization or AIPSCB.

All the Dope penalties (Administrative and Individual), if imposed by any Federation on AIPSCB, would be paid by the concerned organisation to which the sportsperson belongs to. (w.e.f. December 14, 2017). The concerned organisation will also be banned for one year (w.e.f. 2012 onwards) for taking part in

that particular event during the next year's championship organised under the aegis of AIPSCB.

33 All India Police Sports Control Board will provide financial assistance ranging from Rs. 6 to 30 lakhs depending on the nature & size of the national competition for police personnel only organised by any state/UT Police Forces or CPOs under the aegis of AIPSCB. (Joint meeting of Board members, April 9, 2015 and also reallocated following the meeting).

34 AIPSCB would allot the calendar of events on rotation basis during the DGP/IGP Conference every year (Board Meeting January 11, 2010).

35 Any sporting event recognised by Indian Olympic Association/concerned National Sports Federation to which AIPSCB is affiliated to, or as per the list of DoPT, can be included in All India Police Games. AIPSCB events for women like Kayaking, Canoeing, Rowing, Gymnastic & Wrestling will also be held if 10 or more teams in each event are available with the States/UT Police Forces & CPOs. In the event of less than 10 teams medals/trophies will not be given and the competition will be treated as show matches only.

AIPSCB (New Delhi, January 11, 2012) shall provide relevant full kit items to all team members including manager, coach & doctor participating in National Championships.

CONDUCT/OFFICIALS

Since Shooting Sports is highly technical with micro scoring system, demanding expertise, fair and transparent conduct, the AIPSCB will nominate a Technical Conduct Committee – preferably headed by a Senior most Retd Police officer, having expertise and ISSF qualification as a judge, associated with adequate No.of ISSF qualified retired or serving Police officials. If need be additional qualified listed NRAI official can be added with this technical conduct committee for efficient and smooth conduct of the competition. Organising State/CPO will be responsible for all kind of administrative arrangements and deputing supporting staff, arrange required equipment, target system on all ranges, however all technical decision will be taken by Technical Conduct Committee (TCC) under its Chairmanship. Decision of Chairman/TCC will be final.

ELIGIBILITY FOR PARTICIPATION

Competition is open to all ranks of CPO/State Police forces who have completed 3 months continuous service are eligible to participate. All Central Police & State/UT Police Forces affiliated to All India Police Sports Control Board must participate.

In view to give wider opportunity, no competitor can participate in more than two events in any one category of weapon (i.e. Rifle or Pistol). However, he/she can enter/compete in a maximum of three events if participating in both the categories Rifle & Pistol. (for example – one person can compete 02 events in Pistol matches and one in Rifle matches and vice versa).

Target model weapons/equipments as per ISSF specification will be used which will be subject to check for correction by Weapon & Equipment Control Official. Weapons and Equipments used by a competitor should be on the charge of respective organisations. All CPOs/States must have adequate number of relevant weapons and ammunition to avoid weapon sharing. No separate/additional details/lanes will be allocated.

A competitor shall not be allowed to replace his weapons/equipments during the progress of a particular match without prior approval of the Chief Range Officer. However, new weapon/equipment will have to be checked and certified by the Weapon and Equipment Control Official. Host Organization will not provide any arm/ammunition to the participating teams/competitors. As far as possible, unjacketed ammunition may be used during the competition.

Misfire, stoppage and malfunctions will be allowed as per the ISSF Rules in respective events.

ENTRIES:

Event-wise entries with one Reserve must be submitted with prescribed entry fee to organisers at least one month before. Any change can finally be submitted to Classification/Record office before Managers' Meeting on venue. No last movement changes will be accepted.

Scoring will be done as per ISSF Rules. Nominated Chief Classification Officer by Conduct Committee will be responsible for declaration of results after each match/event.

Paper targets to be used, must be of ISSF specifications.

During the competition, specific safety requirements shall be adhered to strictly. Besides these, general safety rules depending upon Ranges may be notified by the Conduct Committee and must be adhered to.

Use of telescope/spotting scopes for viewing respective targets is permitted. However, no weapon having a telescope as its attachment shall be allowed in the competition.

PROTESTS:

Verbal protests on respective Range and written protests by paying Rs.2500/within 30 minutes of the happening or display of result. In case of any valid correction in result by the Classification Officials/RTS, the result will be altered accordingly. In case, the claim of the firer is found to be wrong, the protest fee shall be forfeited. If claim is sustained, the said fee will be refunded. Results of RTS on electronic targets will be final and non protestable.

In case, Team Manager/Captain is not satisfied with the decision of the relevant officials, a written protest addressed to Chairman, Technical Conduct Committee may be made within 30 minutes from the announcement of previous decision along with fresh deposition of Rs.2500/- being the additional review protest fee. On receipt of such protest target or issue will be re- examined and the targets will not be disposed off till the final disposal of the protest by the Technical Conduct Committee. The decision of the Technical Conduct Committee shall be final.

RESULTS:

First 03 individual medals will be decided in order of merit (points) and team positions for trophies will be decided on team performance in each event/category.

Teams scoring position upto 6th place in a particular match shall be awarded points as under to decided team championship.

Team position in 1 2 3 4 5 6 each event 2 Points to be allowed 4 1 6 5 3 Best shooters will be declared in Men & Women category having highest Medals &

points (as per top 06 position) achieved by the concerned individual.

Any change in pattern for calculating/deciding championship must be notified well in time before competition.

PENALTIES & DISQUALIFICATION:

As per ISSF latest rules or rules so supplemented by AIPSCB, any indiscipline, misconduct, unpleasantness or safety violation will be liable for disqualification. Keeping in view the safety, available ranges, infrastructure, target system etc, the Chairman, Technical Committee is authorised to notify any additional instructions during the Technical Committee meeting before commencement of the competition, which will be a binding on all.

RULES OF ALL INDIA POLICE ARCHERY CHAMPIONSHIP

<u>General</u>

To promote this ancient game and in order to encourage talented police archers, the All India Police Sports Control Board has decided to include Archery event in sports calendar of All India Police Sports Control Board and will be organized every year on rotation basis. Recurve and Compound division matches will be conducted under World Archery (WA) Federation Rules formerly known as Federation International DTR Archery (FITA) whereas Indian Round will be conducted as per the rules of Archery Association of India.

Events to be conducted

The following sports events shall be conducted in men/women categories:-

- 1. Recurve Division, Men/Women (Individual/Team events) 90M, 70M, 50M, 30M (Men) 70M, 60M, 50M, 30M (Women)
- Compound Division, Men/Women (Individual/Team events) 50+50M (Men) 50+50M (Women)
- Indian Round, Men/Women (Individual/Team events) 50M, 30M (Men) 50M, 30M (Women)

Olympic Round / Elimination Round.

- 1. Recurve Division, Men/Women (Individual/Team events)- 70M
- 2. Compound Division, Men/Women (Individual/Team events)-50M
- 2. Indian Round, Men/Women (Individual/Team events)-50M

Mixed Team Event

Recurve Division Mixed team Compound Division Mixed team; and Indian Round Mixed team.

Team composition

Team composition shall be minimum 3 and maximum 4 players per division. One player/team can participate in any two divisions.

Technical Committee

The host organization shall appoint a Director of shooting, Judges, field officials, technical committee, scoring committee as per requirement of the competition. All Judges, Director of shooting and technical committee shall have a AAI accreditation and must be nominated by the Archery Association of India or by the concerned State Archery Association. However, in case of shortfall of accredited officials, the host organization/executive committee can nominate eminent sportspersons of various States/CPOs as technical officials for the competition.

Eligibility for participation.

This competition is open to all ranks. All State/UT Police Forces & CAPFs are eligible to participate. The States/UT Police Forces/CPOs should ensure that only those archers are included in the team who are appointed as permanent basis of the organization. No casual or temporary appointees would be allowed to participate in the competition. A certificate/undertaking to that effect should be furnished and attached with the entry form duly signed by the competent authority (IGP) in respect of newly appointed archers.

Equipments

Equipments used by the competitor during Recurve and Compound Division matches should be as per the specification of World Archery Federation. In Indian Round competition, equipments used by the competitor should be as per the specification of Archery Association of India.

Medal/Trophies

3 trophies viz. Winner, Runners-up & Hardliner trophies will be awarded to the winner teams. Award of trophies will be decided on medal telly. 32 Sets of Gold, Silver & Bronze medals in men category and 26 Sets of medals in women category will be awarded. Medals in women category will be awarded only if 10 or more teams are available to participate. Beside above, a pure silver medal for best archer (Men/Women) will also be awarded.

Appendix 'B'

Opening Ceremony

The Chief Guest arrives. He is received by the DGP/IGP of the host State/CPO. The band salutes the Chief guest. The DGP/IGP presents members of the Jury of Honour and Appeal, the members of the Organising Committee and Managers of the participating teams. The Chief Guest is then conducted to the rostrum.

2. The Opening Ceremony commences with the march past in columns of three by the athletes/players. The Chief Guest is requested by the DGP/IGP to take the salute. The participating teams in the march past maintain an interval of fifteen paces between one another. Members of a particular contingent should wear identical dress, be it tracksuits, blazers, pant/vest etc. Each contingent is preceded by a person carrying a placard bearing the name of the team and is led by the Captain of the team carrying its flag (3'x2' on a 8' pole). The placard bearer marches five paces ahead of the flag bearer who in turn is five paces ahead of the team. The teams march past in alphabetical order of their names except the host team, which comes at last. The contingents pay compliments to the Chief Guest when they approach the rostrum by turning their heads to the right and by dipping their flags to the right at an angle of about 50 degree, on the command 'Eyes Right' given by the Captain of each team. After passing the rostrum, the Captain gives the command 'Eyes Front' and brings his flag to carry position.

3. Each team, after completing its march, forms up in column of threes behind its placard and flag around the track facing inward in arch format. The band stops as the last team comes to a halt. After a brief pause, the band resumes playing and the teams march inwards and come to a halt in a semicircle facing the Tribute of Honour and stand at ease.

4. The DGP/IGP delivers a short speech of welcome from the rostrum. At the conclusion of his speech, the DGP/IGP requests the Chief Guest for his speech and thereafter request him to declare the meet open in the following words:-

"I have the honour to request Shri______to proclaim the All India Police______, Championship open."

5. The Chief Guest declares the Meet open with the words : "I declare the All India Police_Championship open."

6. Immediately a fanfare of trumpets is sounded, the teams come to attention and All India Police Sports Control Board flag is unfurled near the Tribune of Honour. Simultaneously, the flags of the participating States/CPOs (6'x4') hoisted around the area are unfurled. As soon as the fanfare is over, pigeons and balloons are released and general jubilation is expressed by firing of Feude-joie, very light pistols (multi-coloured), crackers, fireworks and playing of joyous music on the 'Shehnai' and beating of drums.

7. The Captain of the host State team gives the command "Team Captains- Quick March". The Captains carrying their flags march forward fifteen paces, forming an inner semicircle in front of the Tribune of Honour. The Captain of the host State team advances further to the foot of the Tribune of Honour where he comes to a halt and plants his flag in the ground. The other captains also rest their flags on the ground. The Captain of the host State team advances further to mounts the Tribune of Honour and facing the Chief Guest raises his right hand while holding a corner of his flag with the left hand. The members of all teams raise their right hand and the captains dip their flags as the Captain of the host team pronounces the following oath on behalf of all the assembled athletes/players.

"We swear that we will take part in All India Police

Championship in fair competition, respecting the regulations, which govern them and with the desire to participate in them in the true spirit of sportsmanship for the honour of our nation and the glory of sports."

8. On the conclusion of the oath, the flags are raised and the team Captain of the host State steps down from the Tribune of Honour. The team Captains rejoin their respective teams on the words of command "Team Captains – About Turn, Quick March".

9. The Chief Guest leaves.

10. The athletes/players march away in column by the shortest route in the same order in which they entered the stadium followed by the band.

<u>N.B.</u> (i) In case the host so decides, a cultural programme can be arranged (as the last item of the opening ceremony) in the ground after the teams have marched away. Accordingly, the Chief Guest is also requested by the host to witness the cultural programme.

(ii) In case of the opening ceremony of the Athletics Championship, a torchbearer (usually a renowned sports person himself) takes a lap on the track before lighting the flame in the stadium, which would burn till the conclusion of the Athletics Meet. Sequentially, this exercise pertaining to lighting of the flame would come after the conclusion of item No. 3 above and before the start of item No. 4 (DGP's speech).

Closing Ceremony

1. The Chief Guest arrives. He is received by the DGP/IGP of the host State/CPO and the Chairman, All India Police Sports Control Board, in his absence, Secretary of the Board or representative of the Chairman, AIPSCB. The band salutes the Chief Guest. The DGP/IGP presents Members of the Jury of Honour and Appeal, members of the Organising Committee and Managers of the participating teams. The Chief Guest is then conducted to the rostrum. The Chief Guest is requested by the host DGP/IGP to take the salute at the March Past of athletes/players. The champion team leads the March Past while the host State/Unit comes last; the other teams march past in alphabetical order of their names. The teams then form a semicircle facing the Tribune of Honour.

2. The DGP/ADGP or any other senior officer of host organization delivers welcome address and thereafter requests the Chairman, AIPSCB or his representative to deliver his address.

3. The Chairman or his representative address the gathering and thereafter request the Chief Guest to give away the trophies and thereafter address the gathering.

4. The Chief Guest gives away the trophies.

5. The Chief Guest address the gathering,

6. It is the prerogative of the Chairman, AIPSCB to declare the meet closed. As it is not possible for the Chairman to attend all the closing ceremonies, in his absence Secretary, AIPSCB or representative of the Chairman would declare the Championship closed. In case Governor or Chief Minister/Union Minister is the Chief Guest, the host organisation can get the meet closed by the Chief Guest after obtaining prior permission of the Chairman. The meet would be declared closed in the following words.

"I declare the All India Police_____Championship, _____closed.

7. The 'retreat' is sounded and simultaneously the All India Police Sports Control Board flag and also the flags of the competing teams are lowered. Team captains dip the flags, carried by them and bring them to the carry position as soon as the retreat is over.

8. The All India Police Sports Control Board flag is then folded and carried at the slow march (Auld Lang Syne) by four players of the host State and handed over to the Chief Guest who makes it over to the DGP/IGP of the host State, with the following declaration.

"I deliver this flag to you for safe custody until such time as it is again flown at the next All India Police_____Championship".

The DGP/IGP of host State receives the flag and replies. "This duty I willingly undertake to perform".

9. The Chief Guest departs.

10. At the command of a drumbeat, the flag bearers form up in a line on the right of the Tribune of Honour. At the time of the second drumbeat, the competitors fall in behind these rows of flags, one file behind each flag. There shall be no distinction of teams while falling in. The competitors from different States/CPOs should mingle and march out in the true spirit of sportsmanship of friendly competition, waving out in friendship to the spectators as they go out of the arena.

<u>N.B.</u> In case the host so decides, a cultural programme can be arranged (as the last item of the closing ceremony) in the ground after the teams have marched away. Accordingly, the Chief Guest is also requested by the host to witness the cultural programme.

Annexure 'C'

<u>Barra Khana</u>

The host of the Games organises a community dinner ('Barra Khana') usually on the closing day of the Meet in which all the competitors participate along with senior officers, organisers, referees, judges etc. In view of the large gathering on the occasion, it becomes difficult for the host to cook the food for all the participants at one place in a centralised manner. A better alternative for the host is to give the necessary amount to each participating team calculated at a specified rate per person. Each team would then get the food of its choice including specialities of their particular region/State cooked and bring it to the venue of the 'Barra Khana' for consumption by its members. The host would thus be required to get food prepared only for the guests, senior officers, judges, referees etc.

2. At the venue of the 'Barra Khana', a separate space/stall is allotted to each team for laying their food and consuming it. It is, however, customary for senior officers to visit all stalls apart from their own team, mingle, with the players and boost their morale.

3. In case the host has decided to organise a cultural programme on the occasion, care should be taken that it is held after the 'Barra Khana' and not before it. In other words, the players should first take their food in time and then witness the cultural programme.

Appendix 'E'

Victory Ceremony for individual Events

Medals shall be presented to the winners of the first, second and third positions immediately after the conclusion of a particular individual event. An announcement may be made over the loudspeaker for the medal winners to assemble at the appointed place for medal ceremony. The managers of the respective teams should ensure prompt presence of medal winners at the spot.

2. The medal winners should be made to fall-in in a single file with three ceremonially dressed females carrying medal trays in front of them and the buglers/trumpeters behind them. Another male escort should place himself at the head of the single file and march all of them to the victory stand to the accompaniment of playing of tunes by the band suitable to the occasion.

3. The medal winners stand behind the victory stand at their respective places while the three females carrying the medal trays stand at the flank at right angles to the victory stand with the one carrying the Bronze medal being nearest to the victory stand.

4. Simultaneously, the announcer requests the chosen dignitary to award the medals. The dignitary is escorted by a senior police officer/member of the Organising Committee and as he reaches the victory stand, the medal winners climb the victory stand. The lady carrying the bronze medal tray then steps forward, the escort lifts the medal and passes it on to the dignitary who presents it to the winner by placing it around his/her neck. The same process is repeated for silver and gold medal winners.

5. The fanfare of trumpets/bugles is sounded as the dignitary and the escort turn around and stand in front of the victory stand to facilitate taking photographs. Thereafter, the dignitary is escorted back to his seat and the medal winners led by the ladies are marched away.

NB: For team games, however, the medals as also the trophies to the winners will be distributed at the time of the closing ceremony of the Games.

INSTRUCTIONS FOR HOST/WINNING ORGANIZATIONS.

- 1. The responsibility of safe custody of Trophies lies with winning team of the year. Any damage or loss caused during transit will be made good by the organisation concerned.
- 2. Trophies shall be returned to the Secretary, All India Police Sports Control Board for maintenance/polishing at least 45 days before commencement of the next championship.
- 3. Trophies should be properly packed in bubble film and other materials to avoid any damage in transit before sending the same to AIPSCB.
- 4. The trophy collection party of host State/CPO reporting AIPSCB for the purpose should check thoroughly all the trophies and their quality of polishing before receiving thereon
- 5. Due care and caution should be exercise while transportation of trophies to avoid denting/damage, etc.
- 6. At any stage the Host Organisation should not use wet cloth for shinning the trophies as it may lead to blackening trophies rather than improvement in shining.

INSTRUCTIONS FOR CONTRACTOR

- 1. Trophies would be handed over to the contractor at least 20 days before commencement of the closing ceremony of the championship for polishing.
- 2. The contractor should wrap the trophies in airtight polythene after polishing to avoid oxidation /blackening.
- 3. The trophies should be further wrapped in bubble film and properly packed to prevent denting during transportation.
